

- 2. UPPER FILLING DEVICE
- 3. LOWER FILLING DEVICE
- 4. KNOCKBOX BASE

FUTUROLA KNOCKBOX

OPERATING INSTRUCTIONS

READ THOROUGHLY BEFORE USE

ASSEMBLING THE KNOCKBOX

NOTE: IT IS RECOMMENDED TO USE A SURGE PROTECTOR (NOT INCLUDED).

- PLACE MIX SPILL COLLECTOR ON THE BACK OF KNOCKBOX BASE, ALIGNING THE MAGNETS FOUND ON EACH PIECE.
- PLACE UPPER/LOWER FILLING DEVICE FROM FILLING KIT ON TOP OF KNOCKBOX BASE, ALIGNING THE MAGNETS FOUND ON EACH PIECE.
- 3. PLACE **MIX TRAY** ON TOP OF **UPPER FILLING DEVICE**, ANCHORING THE SCREWS INTO THEIR ALIGNMENT HOLES.
- PLUG CONTROLLER INTO THE PORT ON KNOCKBOX BASE, AND SCREW TO TIGHTEN.

NOTE: DO NOT PULL CORD. UNSCREW TO DISCONNECT CONTROLLER.

PLUG POWER ADAPTER INTO CONTROLLER PORT.

MAINTAINING THE KNOCKBOX

THE KNOCKBOX HAS A SELF-CLEANING MECHANISM WHICH WILL PREVENT MOST ACCUMULATIONS OF HERBAL MIX ON THE KNOCKBOX BASE. SPOT CLEANING CAN BE ACHIEVED WITH COMPRESSED AIR DUSTERS. IF FURTHER CLEANING IS DESIRED, GENTLY WIPE THE AFFECTED AREAS WITH A LIGHTLY SATURATED CLOTH OR CLEANSING TOWELETTE.

DO NOT SUBMERGE KNOCKBOX BASE, CONTROLLER, OR POWER ADAPTER IN WATER, OR ATTEMPT TO CLEAN WITH EXCESSIVE AMOUNTS OF LIQUID OR CLEANING SOLUTION.

THE **FILLING KIT** CAN BE CLEANED IN A SOLUTION OF HOT, SOAPY WATER OR RUBBING ALCOHOL. DRY THOROUGHLY BEFORE USE.

OPERATING THE KNOCKBOX

- 1. REMOVE MIX TRAY FROM FILLING KIT.
- 2. DROP ONE PRE-ROLLED CONE INTO EACH HOLE OF THE FILLING KIT.
- 3. PLACE HERBAL MIX IN THE LID OF **BOX 1**, OR DESIRED CONTAINER.
- 4. SCOOP HERBAL MIX ONTO **MIX TRAY** AND SCRAPE ACROSS THE HOLES, ENSURING NOT TO FORCE MIX INTO THE HOLES.

NOTE: FORCING MIX INTO THE HOLES WILL RESULT IN UNEVENLY FILLED CONES.

- REPEAT PREVIOUS STEP UNTIL ALL HOLES ARE FILLED EVENLY.
- 6. RETURN MIX TRAY TO FILLING KIT.
- 7. SELECT HIGH OR LOW DENSITY ON CONTROLLER.

NOTE: IT IS RECOMMENDED TO USE THE HIGH DENSITY SETTING FOR MOST HERBAL MIXES.

- 8. PRESS THE START BUTTON ON CONTROLLER.
 - NOTE: THE KNOCKBOX SELF-CLEANING MECHANISM WILL START APPROXIMATELY 5 SECONDS BEFORE THE FILLING CYCLE.
- ONCE THE FILLING CYCLE STARTS, QUICKLY REMOVE THE METAL SLIDE FROM MIX TRAY.

NOTE: IF HERBAL MIX DOES NOT FALL FROM THE HOLES, LIGHTLY TAP THE MIX TRAY WITH THE METAL SLIDE UNTIL ALL MIX FALLS INTO THE PRE-ROLLED CONES.

- FOR 1.0_G CONES, RETURN METAL SLIDE TO MIX TRAY AND REPEAT STEPS
 4-9. FOR 0.5_G CONES, REPEAT STEP 8 ONLY.
- 11. ONCE THE FILLING CYCLE IS COMPLETE, REMOVE MIX TRAY AND UPPER FILLING DEVICE FROM LOWER FILLING DEVICE.
- 12. REMOVE MIX SPILL COLLECTOR.
- 13. PLACE **UNLOAD STATION** ON THE BACK OF **KNOCKBOX BASE**, ALIGNING THE MAGNETS FOUND ON EACH PIECE.
- 14. CAREFULLY SLIDE **LOWER FILLING DEVICE** ONTO **UNLOAD STATION**, ALIGNING IT INTO THE SLOT.
- 15. QUICKLY REMOVE PLASTIC SLIDE FROM UNLOAD STATION.
- 16. REMOVE LOWER FILLING DEVICE FROM UNLOAD STATION.
- CLOSE EACH PRE-ROLLED CONE BY FOLDING THE EXCESS PAPER OVER THE TOP.

NOTE: IT IS NOT RECOMMENDED TO TWIST THE TOPS OF THE CONES, AS THIS IS KNOWN TO CAUSE UNEVEN BURNING.

- 18. REMOVE PRE-ROLLED CONES FROM **UNLOAD STATION** AND PLACE INTO STORAGE TUBES.
- REASSEMBLE KNOCKBOX FOR FURTHER USE, OR PLACE IN BOXES 1 & 2
 FOR STORAGE.

LIMITED WARRANTY

THIS LIMITED WARRANTY APPLIES TO THE FUTUROLA KNOCKBOX 2 ("KNOCKBOX") PURCHASED FROM FUTUROLA USA, LLC ("FUTUROLA") AND AUTHORIZED DISTRIBUTORS.

WHAT DOES THIS LIMITED WARRANTY COVER?

THIS LIMITED WARRANTY COVERS ANY MATERIAL OR MECHANICAL DEFECTS OF THE KNOCKBOX UNDER NORMAL USE DURING THE WARRANTY PERIOD. DURING THE WARRANTY PERIOD, AT THE FULL DISCRETION OF FUTUROLA MAY CHOOSE TO REPAIR OR REPLACE, AT NO CHARGE, PRODUCTS OR PARTS OF A PRODUCT THAT PROVES DEFECTIVE BECAUSE OF IMPROPER MATERIAL OR WORKMANSHIP, UNDER NORMAL USE AND MAINTENANCE. THIS LIMITED WARRANTY EXTENDS TO THE ORIGINAL PURCHASER ONLY AND IS NONTRANSFERABLE.

WHAT DOES THIS LIMITED WARRANTY NOT COVER?

THIS LIMITED WARRANTY DOES NOT COVER ANY PROBLEM THAT IS CAUSED BY: CONDITIONS, MALFUNCTIONS OR DAMAGE NOT RESULTING FROM DEFECTS IN MATERIAL OR WORKMANSHIP CONDITIONS, MALFUNCTIONS OR DAMAGE RESULTING FROM NEGLIGENCE, IMPROPER MAINTENANCE OR MODIFICATION. DAMAGED OR DESTROYED BY NATURAL CAUSES INCLUDING BUT NOT LIMITED TO LIGHTNING, FLOOD, OR OTHER NATURAL DISASTER.

THEFT OR LOSS OF THE KNOCKBOX.

THIS LIMITED WARRANTY DOES NOT COVER ANY SHIPPING CHARGES, HANDLING CHARGES, OR TAXES. YOU ARE RESPONSIBLE FOR AND MUST PREPAY ALL SHIPPING CHARGES.

YOU SHALL ASSUME ALL RISK OF LOSS OR DAMAGE TO THE KNOCKBOX WHILE IN TRANSIT TO AND FROM FUTUROLA.

THIS LIMITED WARRANTY IS VOID IF THE KNOCKBOX IS RETURNED WITH REMOVED, DAMAGED OR TAMPERED LABELS OR ANY ALTERATIONS.

HOW LONG DOES THE COVERAGE LAST?

THE WARRANTY PERIOD FOR A KNOCKBOX PURCHASED FROM FUTUROLA AND AUTHORIZED DISTRIBUTORS IS ONE YEAR FROM THE DATE OF SHIPMENT. A REPLACEMENT KNOCKBOX OR PART ASSUMES THE REMAINING WARRANTY OF THE ORIGINAL KNOCKBOX.

WHAT DO YOU HAVE TO DO?

TO OBTAIN WARRANTY SERVICE, CONTACT FUTUROLA TO REPORT THE CLAIM. WARRANTY SERVICE WILL BE FULFILLED AT THE DISCRETION OF FUTUROLA. AFTER THE CLAIM IS APPROVED, DELIVER THE KNOCKBOX, IN ITS ORIGINAL PACKAGING, INCLUDING ANY ACCESSORIES OR DOCUMENTS THAT SHIPPED WITH THE KNOCKBOX TO THE ADDRESS SPECIFIED BY FUTUROLA. FUTUROLA WILL REFUSE THE RETURN OF KNOCKBOXES WHICH ARE NOT PROPERLY CLEANED OF ALL DEBRIS.

IMPLIED WARRANTIES


